- 2. Copy of State Charter/certificate
- 3. Copy of most recent financial statement
- 4. Copy of 501C(3), if applicable
- 5. Copy of Consumer Certificate of Exemption
- 6. Specific use of the property

Educational Institutions

- Copy of Accreditations or Membership of the State Department of Education of Florida, Southern Association of Colleges and Secondary Schools or the Florida Council of Independent Schools
- 2. Or, affidavit of eligibility for accreditation by any of above organizations
- 3. If Day Care, gold seal designation, is required
- 4. If Charter School, a copy of the charter is needed and an affidavit from the owner if the property is leased. Click link for application (DR-504CS)

Hospitals, Special Care, CCRC, etc.

- 1. Copy of Articles of Incorporation or by-laws
